## International Science & Consciousness Conference, Albuquerque, April 1999

Ronald Russell writes: Some 530 people packed into the dizzying heights of the Crowne Plaza Pyramid on the northern edge of Albuquerque for the first International Science and Consciousness Conference. (NB 'and' not 'of'). This was not much like Tucson; focus was mainly on the 'softer' end of the spectrum and there was little, if any, mention of phenomenology, qualia or even cognitive neuroscience. Keynote presenters included Edgar Mitchell, Peter Russell, the cosmologist Brian Swimme, Larry Le Shan and Paul Pearsall from Hawaii, author of 'The Heart's Code'. The harder sciences were represented by, among others, William Tiller and Amit Goswami; the influence of music on consciousness was discussed and demonstrated by Steve Halpern and Jacotte Chollet; Jeffrey Misholove held workshops on the paranormal; Huston Smith and Robert Forman, as well as Peter Russell, took the subject into the mystical/spiritual areas. Stanley Krippner talked on shamanic states, dreams and myths, Christian de Quincey showed that philosophy's pursuit should be Wisdom rather than Truth; and Beverly Rubik, Ralph Metzner, Brian O'Leary, Elisabet Sahtouris, Carlos Warter and Swami Beyondananda were among a host of others who blended ideas and information with entertainment, revealing how very multi-faceted, and how approachable, the subject is. The Conference will be held at the same venue next year, by which time Albuquerque will have advanced even further into the desert. It should be well worth attending.

## "Technology Protection System" (TPS) -Terminator Technology.

Bob Mueller writes: The USDA, spending public money, has developed a technology whereby seeds can be stripped of their ability to propagate. They are in the process of patenting the process world wide on behalf of Monsanto, through a subsidiary (Delta and Pine Land Company). The driving force behind the Terminator technology is the ability for the companies to protect their "inventions" from being "duplicated" unlawfully, which, granted, sounds appropriate and fair. The result, however, will be to replace natural crops world wide, with genetically enhanced, superior, high yield crops. Superior, that is, except for the fact that they can no longer reproduce hemselves, effectively forcing farmers world wide to buy their seeds annually from Monsanto...the world's only supplier. The patent applies to ALL PLANTS.

This is the ultimate in Capitalism. We're going to remove nature's ability to propagate herself, so we can charge money for that privilege.

However, I only wish this were the full extent of the issue. Martha L. Crouch, Associate Professor of Biology at Indiana University, has published a series of papers specifying how the resulting castrated plants WILL be able to sterilise nearby normal species, via the spread of Terminator pollen. Not only that, but how these plants will be able to actually pass the toxin gene to other plant species through cross-pollination: See http://www.bio.indiana.edu/people/terminator.html

Yet this "product" has been virtually assured of being passed as safe, in the USDA's own words: "These approvals are expected because there appear to be no crop or food safety risks to the new technology. ## **OECD Environmental Indicators**

OECD has just published its tables of key environmental indicators under the rubric of 'Towards Sustainable Development'. Its purposes are 1) to keep track of environmental progress 2) to ensure that environmental concerns are taken into account when policies are formulated and implemented and 3) to ensure similar integration of environmental concerns into economic policies, mainly through environmental accounting. So far, OECD countries have agreed to use the pressure-state-response (PSR) model as a common harmonised framework, and the indicators are regularly used in environmental performance reviews. The publication contains an impressive level of detail on such topics as climate change, ozone layer depletion, water and air quality, forest and fish resources, and biodiversity, with graphs and tables related to GNP and per capita output of, say,, emissions. This is followed by another section on socio-economic indicators on transport, energy, agriculture etc. A good companion to the State of the World analyses from the WorldWatch Institute. ## **Aviation Climate Effect "could grow four-fold"**

Climate emissions from air transport will continue to increase and could account for 15% of total human-induced global warming effects by 2050, according to an international scientific panel report just published. The report is expected to strengthen debate over how aviation emissions can be incorporated into greenhouse gas reduction commitments under the Kyoto protocol. Prepared over two years by the Inter-governmental Panel on Climate Change (IPCC), the report calculates that aviation was already to blame for 3.5% of total global warming in 1992, and that projected growth in passenger and freight transport will ensure that it accounts for at least 5% and perhaps as much as 15% in fifty years time. Fuel consumption is expected to rise from 130m tonnes in 1992 to 300m in 2015 and 450m in 2050. Contacts: UNFCCC (http://www.unfccc.de). ## **World Scientists' Statement on GM Crops**

This statement was launched at a conference in Columbia at a UN Convention on Biological Diversity and calls for an immediate moratorium on further environmental releases of transgenic crops, food and animal feed products for at least five years, a ban on patents on living organisms, cell lines and genes, and support for a comprehensive, independent public enquiry into the future of agriculture and food security for all, taking account of the full range of scientific findings as well as socioeconomic and ethical implications. The Statement itself is tightly drafted and is supported by a lengthy technical supplement. All of this can be

## Study of Medical Students' Health in Croatia

Based on the analysis of 521 questionnaires, this survey found that 42% of students blamed their current education for a deterioration in their health. Of these, 35% reported emotional and 356% physical symptoms and 11% have actually been diagnosed with one or more diseases related to studying. Among the interesting findings were the prevalence of vision deterioration, headaches and digestive problems, the 45% reporting specific stress related conditions including lack of sleep and, ironically, paying less attention to their own health! The co-ordinator, Petar Kresimir Hodzic, is now interested in extending his study to other countries.
